Before this appointment, Dr. Liu has worked at Harvard University in the areas of global health and health systems for almost 20 years, serving as the founding Director of Harvard School of Public Health China Initiative since 2006. He has worked in many African and Asian developing countries. In particular, he has been closely involved in helping inform China's health policy making process for series of reforms and strategic developments. Since 2006, he has been leading the Harvard China Initiative to conduct series of high impact programs in healthcare reform research, leadership development and policy dialogues. Dr. Liu also served on the United Nations Millennium Development Taskforce on HIV/AIDS, Malaria, TB, and Access to Basic Medicines. He consulted for many international agencies including the World Health Organization, World Bank, Asian Development Bank, UNICEF. He is also an Adjunct Professor of Health Policy at Tsinghua University and serves on the Experts Committee of Health Policy and Management of the State Health and Family Planning Commission.

He is on the Scientific Advisory Board of the Earth Institute at Columbia University and the Advisory Council of the Paul G. Rogers Society for Global Health Research.

Dr. Bloom came to HSPH to serve as dean of the faculty in 1998. He stepped down on December 31, 2008, and is currently a Harvard University Distinguished Service Professor at HSPH. In his capacity as dean, he served as secretary treasurer for the Association of Schools of Public Health (ASPH).

Dr. Bloom holds a bachelor's degree in biology and an honorary D.Sc. from Amherst College and a Ph.D. in immunology from Rockefeller University.







Two projects address policy issues of the United States. Hsiao and his colleagues developed a large scale simulation model that intends to assess the fiscal and health impacts produced by various national health insurance plans. Using time series/cross-sectional data, Hsiao's team designed a multi-equation model that employs a number of variables to predict utilization rates and prices of health services. This model also predicts total health expenditures from supply and demand variables, giving special attention to supply variables, such as physician and hospital beds per capita, availability of primary care physicians, and new technologies. The second project further expands his previous work on the resource-based relative value scale (RBRVS) by packaging physician services into episode of illness, and examines variation in resource input costs by quality of service.

Comparing health systems across industrialized nations, Hsiao applies political and economic theories to develop a structural framework of essential elements of health systems. His team uses econometric models to test various hypotheses and to estimate the extent to which each structural element influences health expenditures and health status. Employing his systemic framework, he is assisting Taiwan, Cyprus, Mexico, Colombia, China, and Sweden in their health systems reforms.

In developing nations, Hsiao's research focuses on the development of sustainable financing mechanisms to provide health care for the poor, rural population, and urban workers. With UNICEF's support, he collaborates with seven universities in China to conduct a nationwide study on health care financing and provision for 100 million poor Chinese. Meanwhile, with the support of The World Bank, he is launching a large scale social experiment on community financing for the rural Chinese population, involving 100 communities and two million people.

Friedman School of Nutrition Science and Policy at Tufts University. Since receiving his doctoral degree in Epidemiology from the Harvard School of Public Health more than 25 years ago. Dr. Jacques has applied his knowledge of epidemiology to the study of nutrition and aging. His research has examined the role of nutrition in age-related disorders such as atherosclerosis, diabetes, cataract, osteoarthritis and dementia. Dr. Jacques is the author of more than 250 original, peer-reviewed research articles and dozens of editorials, book chapters and reviews on nutrition and aging. He has extensive experience working with large cohorts and surveys including the Framingham Heart Study, the Family Heart Study, the National Health and Nutrition Examination Survey, and the Nutritional Status Survey of Boston-area Elderly. Dr. Jacques has also been involved in a number of randomized, placebo-controlled intervention studies examining metabolic and health consequences of altered nutritional status. Dr. Jacques' current research includes the examination of the role of diet on metabolic markers of diabetes and cardiovascular disease risk with an emphasis on whole grains, low fat dairy, flavonoids and overall diet quality; and the impact of FDA-mandated folic acid fortification of enriched cereal-grain products on folate status and health of Americans with an emphasis on the effect of high folate intake in the presence of low vitamin B12 status.

Under Dean Fried's leadership, MSPH has built the nation's first programs on climate and health, a cross-school program that delivers economic evidence on the business case for prevention; has opened the Columbia Center for Aging, and has transformed Columbia University's vision on leadership for creating healthy cities. The have led the U.S. in innovations in public health education that now serve as a model for other schools of public health around the world. Dr. Fried is invited annually to participate in the World Economic Forum and is sought after as a world leading expert in policy and practice for creating successful societies through health and well-being from childhood to oldest age.

Dr. Fried is an internationally renowned scientist in the fields of epidemiology, gerontology and geriatrics who has dedicated her career to the science of healthy aging and creating the basis for a transition to an aging world that benefits all ages. She has led the scientific work to define the new medical syndrome of frailty and its causes and potential for prevention as keys to optimizing health for older adults. She is the co-designer and co-founder of Experience Corps, a community-based senior volunteer program that both supports success of public school children and is, simultaneously, an evidence-based health promotion program designed to prevent frailty, physical disability and cognitive decline among older adults. Prior to becoming Dean in 2008, Dr. Fried served as the Director of the Division of Geriatric Medicine and Gerontology and the Director of the Center on Aging and Health at The Johns Hopkins Medical Institutions.

Dr. Fried is the recipient of numerous awards. Among them, in 2004 a "Living Legend in Medicine" by the U.S. Congress and Fondation IPSEN's 2012 Longevity Prize. Dr. Fried is an elected member of the National Academy of Sciences' Institute of Medicine, as well as the Association of American Physicians. She is a member of the MacArthur Network on an Aging Society and the World Economic Forum's Council on An Aging Society and their Global Task Force on Social Protection.

William Haseltine

威廉哈兹尔廷博士在科学和商界都开展着杰出的工作。1976至1993年,他执教于哈佛医学院和哈佛公 共卫生学院,并担任了两个学术研究部门: 生化药理学部门和人类反转录病毒学部门的创始人和主席。他因在 癌症,艾滋病,和基因方面的先驱性工作而著名。他发表了包括200多篇同行审查的杂志文章,并且是多本 书籍的作者,其中包括2013年发表的《价廉质优、新加坡医疗保健故事》。他是人类基因组科学公司的创始 人,并担任主席和首席执行官直到2004年。他同时是多家生物技术公司的创始人。他所创立的公司目前在市 场上销售7种药物包括治疗狼疮的BENLYSTA、治疗糖尿病的Tanzeum、治疗炭疽感染的ABTRAX(人类 基因组科学公司),治疗多发性骨髓瘤的Velcade(Proscript/白细胞公司),治疗前列腺癌的Provenge (Dendreon公司)以及治疗猫白血病的利血生(创桥生物技术公司)。威廉哈兹尔廷目前是ACCESS国际 卫生公司主席;ACCESS国际卫生公司活跃于美国,印度,中国,新加坡,瑞典菲律宾和摩纳哥。他也是哈 兹尔廷科学和艺术基金会主席、同时是几家创新医疗保健公司的顾问。

哈兹尔廷博士是马德里IE大学顾问委员会的成员,麻省理工学院科赫研究中心,哈佛和麻省理工学院 雷工研究中心,印度理工研究中心和印度创新实业顾问委员会成员。他也担任纽约科学学院的终身总督, 并且是西班牙"Germans TriasiPuio" 健康研究所的顾问。他是布鲁金斯学会,哈佛公共卫生学院健康和 人权FXB中心的董事;纽约-上海大学创新委员会顾问;外交事宜委员会成员;国际援助艾滋病组织董事 会成员。同时他也是中国国际老龄产业协会的主管。

他是大都会歌剧院,纽约大都会博物馆,古根海姆博物馆顾问委员会成员,并且是亚洲协会赞助人中的 一员。他同时担任青年音乐会艺术家,青年管弦乐团和中国艺术基金会的董事成员。

William A. Haseltine PhD has an active career in both Science and Business. He was a professor at Harvard Medical School and Harvard School of Public Health from 1976-1993 where he was Founder and the Chair of two academic research departments the Division of Biochemical Pharmacology and the Division of Human Retrovirology. He is well known for his pioneering work on cancer, HIV/AIDS and genomics. He has authored more than 200 manuscripts in peer-reviewed journals and is the author of several books including Affordable Excellence: The Singapore Healthcare Story published in 2013. He is the Founder of Human Genome Sciences, Inc. and served as the Chairman and CEO of the Company until 2004. He is also the Founder of several other successful biotechnology companies. Companies he has founded account for seven drugs currently on the market including Benlysta for lupus, Tanzeum for diabetes, and ABTRAX for anthrax infections (Human Genome Sciences, Inc.), Velcade for multiple myeloma (Proscript/Leucocyte, Inc.), Provenge for prostate cancer (Dendreon, Inc.), and Leucogen for feline leukemia (Cambridge BioTech. Inc.).

William Haseltine is currently Chairman and President of ACCESS Health International, Inc., a Foundation active in the United States, India, China, Singapore, Sweden the Philippines and Morocco. He is also Chairman Haseltine Foundation for Science and the Arts. He serves as an advisor and bard member of several innovative healthcare companies

Dr Haseltine is a member of the Advisory Board of the IE University, Madrid, the Advisory Council for the Koch Institute of MIT, a member of the Advisory Board of the Ragon Institute of Harvard and MIT, a member of the advisory council of the Council of Scientific and Industrial Research of India, a member of the Innovation Council of Reliance Industries, India, a Lifetime Governor of the New York Academy of Sciences and a member of the advisory board of the Health Research Institute of the "Germans TriasiPuio" Foundation, Spain, He is Trustee of the Brookings Institution, the FXB Center for Health and Human Rights at the Harvard School of Public Health, a member of the advisory council on Creativity and Innovation of the NYU-Shanghai University, a member of the Council on Foreign Relations, a member of the Board of AID for AIDS International. He is a director of the International China Ageing Industry Association.

He is a member of the Advisory Board of the Metropolitan Opera, a Patron of the Metropolitan Museum, the Guggenheim Museum, a member of the Patron's Circle of the Asia Society, a Member of Board of Directors of the Young Concert Artists, the Youth Orchestra of the Americas and the China Arts Foundation.



Barry Bloom, Harvard University Distinguished Service Professor and Joan L. and Julius H. Jacobson Professor of Public Health. Harvard School of Public Health. Boston. USA

A leading scientist in the areas of infectious diseases, vaccines, and global health and former consultant to the White House, Dr. Barry Bloom continues to pursue an active interest in bench science as the principal investigator of a laboratory researching the immune response to tuberculosis, a disease that claims more than two million lives each year. He has been extensively involved with the World Health Organization (WHO) for more than 40 years. He is currently Chair of the Technical and Research Advisory Committee to the Global Program on Malaria at WHO and has been a member of the Technical Advisory Committee of the UNDP/World Bank/WHO Special Program for Research and Training in Leprosy and Tuberculosis Research, and Tropical Diseases. Dr. Bloom serves on the editorial board of the Bulletin of the World Health Organization, the Ellison Medical Foundation Scientific Advisory Board and the Wellcome Trust Pathogens, Immunology and Population Health Strategy Committee. He is on the Scientific Advisory Board of the Earth Institute at Columbia University and the Advisory Council of the Paul G. Rogers Society for Global Health Research.

Dr. Bloom was the founding chair of the board of trustees for the International Vaccine Institute in South Korea, which is devoted to promoting vaccine development for children in the developing world. He has chaired the Vaccine Advisory Committee of UNAIDS, where he played a critical role in the debate surrounding the ethics of AIDS vaccine trials. He was also a member of the US AIDS Research Committee.

Dr. Bloom came to HSPH to serve as Dean of the Faculty in 1998. He stepped down December 31, 2008 and is currently a Harvard University Distinguished Service Professor at HSPH. In his capacity as Dean, he served as Secretary Treasurer for the Association of Schools of Public Health (ASPH). Prior to that he served as chairman of the Department of Microbiology and Immunology at the Albert Einstein College of Medicine from 1978 to 1990, the year in which he became an Investigator of the Howard Hughes Medical Institute, where he also served on the National Advisory Board. In 1978, he was a consultant to the White House on international health policy. Dr. Bloom holds a bachelor's degree in biology and an honorary D.Sc. from Amherst College and a Ph.D. in immunology from Rockefeller University.

Serving on the faculty of the Department of Global Health and Population at Harvard School of Public Health, Dr. Yuanli Liu is founding director of the Harvard School of Public Health China Initiative. Formally launched in 2006, China Initiative aims at helping advance health and social development in China through applied research studies, regular policy dialogues and educational programs for senior Chinese health executives at Harvard and for Harvard students in China. Between 2011 and 2013, Professor Quelch was Dean, Vice President and Distinguished Professor of International Management at CEIBS, China's leading business school. Between 2001 and 2011, he was the Lincoln Filene Professor of Business Administration and Senior Associate Dean at Harvard Business School, teaching Marketing in the Advanced Management Program. 




